

## Reference Guide: Form CMS-2728 Updates in Versions 2023 and 2025

This reference guide provides a description of updated and/or modified field items for the newly updated Form CMS-2728. This guide reflects changes that were made in the 2023 version and additional changes made in the 2025 version. The notes field identifies which changes were made in 2025 and which were made in 2023. This reference guide does not include information about field items that were unchanged in the 2023 or 2025 versions.

Please Note: All required fields in Section A, Section B, and Section F must be completed prior to sending the Form to the Social Security

Administration (SSA).
